On January 18, 2023, the Issuer won a 3-year contract valued at C\$1.5M. Using the Company's Geospatial AI platform and solutions, Government bodies will be able to efficiently conduct and validate crop-cutting experiments, on-field surveys, and other key processes for farmland activities across the state of Uttarakhand, India.
